



Grace Chapel Privacy Policy

Grace Chapel (“Grace Chapel,” “we,” “us,” or “our”) is committed to protecting your privacy and the information you provide to us. This Privacy Policy explains how we collect, use, and protect information when you visit gracechapel.org, interact with Grace Chapel online or in person, submit information through our forms, register for events, communicate with us, or otherwise engage with our ministries and services.

By using our website or providing information to Grace Chapel, you acknowledge the practices described in this Privacy Policy.

1. Information We Collect

We may collect information that you voluntarily provide to us, including:

- Name
- Email address
- Mobile or other phone number
- Mailing or physical address
- Information submitted through forms, registrations, prayer requests, event registrations, volunteer applications, employment applications, or other Grace Chapel communications
- Information related to your participation in Grace Chapel ministries, events, groups, or services

We may also automatically collect certain information when you use our website, including:

- IP address and general device information
- Browser type and operating system
- Pages visited and interactions with our website
- Date and time of website visits
- Other usage and technical information collected through cookies or similar technologies

2. How We Use Your Information

Grace Chapel may use information we collect to:

- Provide ministry services, resources, programs, and information
- Respond to questions, requests, prayer requests, and other communications
- Communicate with you about Grace Chapel ministries, events, services, opportunities, and activities
- Process registrations, donations, volunteer opportunities, employment applications, and other requests
- Send text messages when you have affirmatively opted in to receive SMS communications

- Maintain and improve our website and online services
- Personalize communications and improve your experience with Grace Chapel
- Maintain accurate records and administer our church community
- Protect the security and integrity of our systems
- Comply with applicable legal and regulatory requirements

3. Text Messaging and SMS Privacy

When you provide your mobile phone number and affirmatively opt in to receive text messages from Grace Chapel, we may use your mobile number to send the SMS communications for which you have provided consent.

These communications may include ministry updates, event reminders, scheduling information, service information, administrative messages, or other communications related to your relationship with Grace Chapel.

Grace Chapel does not sell, rent, or share your mobile phone number or SMS opt-in information with third parties or affiliates for their own marketing or promotional purposes.

Mobile phone numbers and SMS opt-in information will not be shared with any third party for purposes unrelated to providing the Grace Chapel communications for which you have opted in.

Grace Chapel may use service providers that assist us in delivering SMS communications and operating our communication systems. These providers may process your mobile phone number and related information solely as necessary to provide services to Grace Chapel on our behalf. They are not authorized to use your mobile information for their own marketing or promotional purposes.

Your consent to receive SMS messages is not a condition of participation in Grace Chapel, attendance at services, or receipt of other Grace Chapel services.

Message frequency varies. **Message and data rates may apply.**

You may opt out of SMS communications at any time by replying **STOP** to a Grace Chapel text message. After you send STOP, you may receive one additional message confirming that your request has been received. You will no longer receive SMS messages from that communication program unless you provide consent again.

4. How We Share Your Information

Grace Chapel does **not sell or rent your personal information.**

Grace Chapel does **not share mobile phone numbers or SMS opt-in information with third parties or affiliates for their own marketing or promotional purposes.**

We may use service providers that assist Grace Chapel with website hosting, communications, registration systems, databases, payment processing, event management, information technology, and other ministry or administrative functions. When these providers need access to personal information to perform services on our behalf, we limit their use of that information to the purposes necessary to provide those services.

In particular, information related to SMS communications, including mobile phone numbers and SMS opt-in information, may be provided to communication service providers solely as necessary to deliver and manage the SMS communications requested by you. Such information is not provided to those providers for their independent marketing or promotional purposes.

We may also disclose information when reasonably necessary to:

- Comply with applicable laws, regulations, legal processes, or governmental requests
- Protect the rights, safety, or property of Grace Chapel or others
- Prevent fraud, abuse, or security threats
- Protect the safety and well-being of individuals when circumstances require it

5. Data Security

Grace Chapel takes reasonable administrative, technical, and organizational measures to protect personal information from unauthorized access, disclosure, alteration, or destruction.

However, no method of transmitting or storing information electronically is completely secure, and we cannot guarantee absolute security.

6. Your Choices and Rights

Depending on applicable law, you may have rights regarding your personal information, including the ability to:

- Request access to personal information we maintain about you
- Request correction of inaccurate information
- Request deletion of information, subject to applicable legal or administrative requirements
- Opt out of certain communications
- Withdraw consent for communications where applicable



You may opt out of Grace Chapel SMS communications at any time by replying **STOP** to a Grace Chapel text message.

7. Cookies and Similar Technologies

Our website may use cookies and similar technologies to improve website functionality, understand how visitors use our website, remember preferences, and support certain website features.

You may be able to control cookies through your browser settings. Disabling certain cookies may affect the functionality of portions of our website.

8. Third-Party Websites and Services

Our website may contain links to third-party websites, applications, or services.

Those third parties may have their own privacy policies and practices.

Grace Chapel is not responsible for the privacy practices, content, or security of third-party websites or services. We encourage you to review the privacy policies of third-party services before providing personal information.

9. Children's Information

Grace Chapel provides ministries and programs for children and students. We seek to handle information relating to children and families responsibly and in accordance with applicable laws and our ministry policies.

Parents and guardians may contact Grace Chapel with questions regarding information collected in connection with children's or student ministries.
